- Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into The Pampered Pet Resort, Inc. as well as any charges for special services requested, and all veterinary costs for the pet during the period said pet is in the care of The Pampered Pet Resort. Owner further agrees that the pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangements are agreed upon by both parties.
- 2. The Pampered Pet Resort, Inc. shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. If interactive daycare is provided. Owner recognizes and accepts potential risks involved in such activity. It is expressly agreed by Owner and pet care provider that The Pampered Pet Resort Inc.'s liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400.00 per animal admitted. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet.
- If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, The Pampered Pet Resort, Inc., in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner.
- 4. The Pampered Pet Resort, Inc. requires a \$3.00 per stay boarding warranty fee. This warranty will expire seven (7) days after the pet leaves The Pampered Pet Resort, Inc. In consideration for the payment of the warranty fee, and subject to the exceptions and conditions following, The Pampered Pet Resort, Inc. will pay up to \$300.00 for any veterinary care provided by a licensed veterinarian for the care or treatment of the boarded pet listed on the agreement for any injury or sickness incurred while the pet is boarding at The Pampered Pet Resort, Inc. Exceptions to this coverage are (1) preexisting health conditions; (2) injury, illness, or death resulting from incidents occurring prior to arrival date: (3) gastric dilation-volvulus (bloat);(4) ACL knee strains or tears;

- The Pet owner hereby agrees to authorize his veterinarian to forward a copy of the diagnosis and treatment history to The Pampered Pet Resort, Inc. Any and all claims under this warranty must be submitted to The Pampered Pet resort, Inc. within seven (7) days from the pet's departure date. Such records are required before any claim is paid. Once received and verified a check will be sent directly to the owner for reimbursement. A signed statement by the veterinarian may be required stating that the illness was not part of/ or caused by a pre-existing condition.
- 5. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Agreement, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
